1. Consignee pay consignor within thirty (30) days of the above described vehicle being sold.
2. That the title shall be provided to the purchaser or application in the purchasers name be made within fifteen (15) days of sale.
3. That the dealer/consignee keeps records for deposit of funds received or handled by dealer/consignee.
4. Dealer/consignee allows inspection by department of motor vehicles of records and accounts.
5. That no payment be accepted by dealer/consignee as commission or fee until transaction is completed.
6. That there be an arrangement for the depositing of money from the consignment transaction with the dealer/consignee upon completed sale.
7. Seller/consignor **MUST DELIVER** title to above described vehicle upon completion of final sale.

Any violation of the above acknowledgements is an illegal consignment and punishable as a CLASS A misdemeanor.

**All acknowledgements below must be initialed by consignor:**

\_\_\_\_\_ Consignor acknowledges and accepts that any and all indebtedness on above described vehicle is his/her sole responsibility, and consignor must maintain any and all agreements with any lending institution with a security interest in above described vehicle.

\_\_\_\_\_ Consignor acknowledges and accepts that he/she will remove any and all personal items from the vehicle prior to consignment, must maintain liability, comprehensive and collision insurance on consigned vehicle for the full term of the consignment. Dealer's insurance provider/carrier **does not** provide any coverage or benefits to consigned vehicles in the event of a loss.

\_\_\_\_\_ Consignor acknowledges and accepts that he/she will hold dealer (Helena RV) harmless from any and all losses from the result of damage or theft to consigned vehicle.

\_\_\_\_\_ Dealer (Helena RV) Consignee makes no claims or agreements to purchasing or making monthly payments on consigned vehicles at any time.

\_\_\_\_\_ Consignor acknowledges that RV must be cleaned inside and out and have sufficient amount of chassis and coach fuel to operate and demonstrate RV to a prospective customer: IE: Half Tank of fuel for chassis if applicable and filled propane tank-tanks on coach

\_\_\_\_\_ Consignor acknowledges and accepts vehicle maybe consigned for up to 90 days. After expiration a re-evaluation of the consigned vehicle agreement and price will take place, and consignor may need to make other arrangements to sell vehicle.

\_\_\_\_\_ Customer acknowledges that any RV being sold to a purchaser will be inspected before delivery for safety and basic component function. Any repairs needed are the responsibility of the consignor unless other arrangements are made and agreed to in writing.

\_\_\_\_\_ Either party may cancel this agreement, cancellation must be made in writing, upon cancellation consignor will have three (3) days to remove vehicle from consignee's place of business. After three (3) days consignor will incur a \$10.00 per day storage fee.

**Vehicle payment details:**

\_\_\_\_\_ Consignor acknowledges any indebtedness to any and all lending institutions will be paid first with left over proceeds being paid to consignor. An original signed and notarized title and lien release must be in possession of consignee before any proceeds can be disbursed to consignor.
